# JOBTRAINER FUND STUDENT FACT SHEET



### WHAT IS THE JOBTRAINER FUND?

The JobTrainer Fund supports job seekers, school leavers and young people to access the skills and training they need to find work, re-enter the labour market or explore new work opportunities available as Queensland's economy recovers. The JobTrainer Fund will operate as a component of Queensland's existing vocational education and training (VET) investment programs and will provide access to additional training opportunities that complement the training already available for the target student cohort.

#### WHAT TRAINING IS AVAILABLE UNDER THE JOBTRAINER FUND?

Subsidies are available for a select number of qualifications and short courses currently in demand by industry. The full list of subsidised qualifications and short courses is available on the *JobTrainer Priority Course List* at <a href="https://desbt.qld.gov.au/training/training-careers/incentives/jobtrainer">https://desbt.qld.gov.au/training/training-careers/incentives/jobtrainer</a>. Additional qualifications and short courses will be added to the priority list on the basis of industry advice on future job demand.

#### AM I ELIGIBLE TO PARTICIPATE?

To be eligible to enrol in a training place funded under the JobTrainer Fund, prospective students must:

- Permanently reside in Queensland and;
- be an Australian citizen, Australian permanent resident (includes humanitarian entrant), temporary resident with the necessary visa and work permits on the pathway to permanent residency, or a New Zealand citizen; and
- have finished school or no longer be at school (including home schooled); and
- not already be enrolled in training (includes VET and higher education courses); and
- not have previously completed a qualification funded under the JobTrainer Fund; and
- either be a job seeker or a school leaver or young person; or
- from 1 October 2021, enrol in an aged care, childcare, disability care or digital skills qualification, and can do so regardless of age or employment status.

In addition to the above eligibility requirements, specific restrictions and/or exemptions may apply to participate in certain subsidised qualifications or short courses, which will be based on industry advice or requirements under the relevant national training package and will be detailed in the *JobTrainer Priority Course List*.

#### WHAT IS THE DEFINITION OF A JOBSEEKER?

- A jobseeker means an individual aged 15 years or older who is:
- Out of work; or
- In receipt of income support payments.

### WHAT IS THE DEFINITION OF A SCHOOL LEAVER OR YOUNG PERSON?

From 1 October 2021, a school leaver or young person means an individual who is aged 16 to 24 years, regardless of employment status. Enrolments prior to 1 October 2021 must be 17 to 24 years.

# WHAT ARE THE NEW AGED CARE, CHILDCARE, DISABILITY CARE OR DIGITAL SKILLS REQUIREMENTS?

From 1 October 2021, prospective students can enrol in an aged care, childcare, disability care or digital skills qualification, regardless of age or employment status. #### WHAT IF I HAVE ALREADY COMPLETED A QUALIFICATION?

Prospective students who have an existing qualification are still eligible to enrol in a subsidised training place as JobTrainer offers people a chance to retrain and gain new skills and qualifications.

# CAN I ENROL IN MORE THAN ONE QUALIFICATION OR SHORT COURSE UNDER THE JOBTRAINER FUND?

Students can only access one training place funded under the JobTrainer Fund to complete an eligible qualification. Students may undertake more than one short course funded through the JobTrainer Fund but cannot be enrolled in more than one short course or qualification at a time.

## WHAT LEVEL OF SUBSIDY IS AVAILABLE?

The subsidy represents the level of government contribution for a qualification and varies between qualifications based on a number of factors. The subsidy payable to approved training providers on behalf of eligible students is detailed on the *JobTrainer Priority Course List*.

## DO I NEED TO CONTRIBUTE TO THE COST OF TRAINING?

Lower level qualifications (up to a certificate III level) and short courses will be fully funded by the Queensland Government, with eligible students required to pay no fee. Higher level qualifications (certificate IV or Diploma level) will be funded at higher concessional subsidies, with eligible students required to pay a low fee of up to \$400. The amount of your out-of-pocket expense will vary depending on the training you undertake and the approved training provider you choose. A co-contribution fee (if required) may be paid on your behalf by an employer or another third party but cannot be paid or waived by the training provider, or any organisation related to the training provider, unless approved by the department.
